IMPORTANT! Cancellation and Refund Policy:

All registration fees are non-refundable for any reason. Should you or your child(ren) choose to withdraw from a class anytime within the first week of classes, Front & Center will fully refund the applicable class tuition fees. **No refunds or credits will be granted for any withdrawals or cancellations after the second week of classes has ended. When registering for the full year, whether two half or one full year of classes, no refund will be given after the second week of the first semester has ended.** Insufficient enrollment in a class by the end of week two of a semester may result in cancellation. In such circumstances Front & Center agrees to offer you either an alternative class or a full refund of applicable class tuition fees. Private lessons must be cancelled or rescheduled at least 24 hours in advance of the lesson. Otherwise, the full amount for the lesson will be charged and no make-up lesson or credits will be granted. Cancelled or missed lessons must be made up within the current semester. **Costumes are non-refundable and non-negotiable.**

Waiver of Liability

I hereby release, indemnify and hold harmless Front & Center for Performing Arts, LLC, its owners, members, advisors, Board of Directors, and all employees and agents of these parties from all liabilities, suits, claims, and/or demands of any kind or nature, legal or financial, whether caused in any way by the negligence or not, arising from the participation in or observation of any Front & Center for Performing Arts, LLC activity for injuries to any person or property, whether on or off the premises. The student/participant named below does voluntarily participate in any and all Front & Center for Performing Arts, LLC activities and that the student/participant and I understand that certain risks are inherent to and from participation and involvement with Front & Center for Performing Arts, LLC and in its various formal and informal activities. Front & Center for Performing Arts, LLC is not responsible for any lost or stolen property, at any time.
