AGE ELIGIBILITY FOR CAMPS IN 2018:

- Our Triple Threat Camp is designed for elementary and middle school children, ages **6-14**, who have completed Kindergarten. Triple Threat Camp will be broken down into smaller groups by age for specific classes during the day.
- Hip Hop/Acro Camp is for ages **6-14**. We are thrilled to be continuing this option for summer. Learn some cool styles, new tricks, and cool moves, or perfect the ones you already know! No experience required. In addition, enjoy some "campy" fun with crafts, scavenger hunts, and more. Groups will be divided by age.

PICK UP AND DROP OFF:

- Drop off begins 10 minutes before each camp start time. Campers will NOT be supervised until that time. Early drop offs or late pickups past 15 minutes will be charged a penalty fee of \$10.00. Unfortunately, we are unable to offer early drop or late pick options.



TRIPLE THREAT CAMP

FOR AGES 6-14

Triple Threat Camp is a classic summer experience and has been a kid favorite at FNC each summer for over 12 years!

This well-rounded program, incorporating classes in acting, voice and dance, allows the young performer the opportunity to improve upon what they do best, as well as trying new skills and having a blast! Each day of the session incorporates classes in all three genres, in which the students not only learn great technique, but also puts it into practice by working on material that will culminate in an informal performance at the end of each session. There are snack and lunch breaks during the course of the day, so please be sure to bring-your-own food and drinks. Campers will need to bring their own lunch and water each day.

Each session is unique, so chose one or both! This is a great environment for your kids to make new friends with others who love to perform or for trying out something completely new! No prior experience required. Each session will be divided up into age appropriate groups.

We will delve into each genre more specifically as well as introduce new topics through special workshops. Past workshops have included Audition Techniques, Costuming and Prop Building, Improvisation, Shakespeare, Monologues, Theatre Dance Techniques, Original Broadway Choreography, Stage Makeup Techniques, Acting for the Camera, and much more.
